- Booking Class: Q base fare with a one way sell-up to H Class for \$50 and one way sell-up to M class for \$125.
- Reservations: 21 & 7 day advance purchase Reservations required 21 & 7 days prior to departure.
- **Ticketing:** For 21 day advance purchase, ticketing is required 21 days before departure or 7 days after booking, whichever comes first; For 7 day advance purchase, ticketing is required 7 days before departure or 7 days after booking, whichever comes first.
- One-way/Circle Trip/Waitlist: Not permitted.
- **Stopovers:** Per published zone fare rules.
- **Open Jaw:** Permitted at either end within the same zone.
- Routing: Via DL Published Y Class Fare.
- Standby: Permitted on same day as ticketed flights.
- Combination: Not valid with other discounts, certificates, coupons or promotional offers.

### Reissues

PRIOR TO ORIGINATION:

- Must be handled by the issuing agency.
- Subject to the applicable reissue fee, voluntary re-routes are permitted, including origin, destination, or connecting points, provided the new itinerary meets the provisions of this fare including advance purchase requirement.

## AFTER TRAVEL COMMENCES:

- Voluntary re-routing is not permitted except changes in day, time or connecting point, provided there is no change in origin/destination and the changes meet the minimum and maximum stay provision.
- An applicable reissue fee will be charged and collected.

## **Unused Tickets**

The difference between the incentive zone fare, less the applicable exchange fee may be applied towards the purchase of a new ticket. Tickets are non-refundable.

### Name Changes

For zone product only, one (1) free name change is permitted per original ticket. No change to date, origin, destination, or stopover points is allowed. All other rules in this agreement must be adhered to for the replacement passenger. Additional name changes will be permitted subject to the applicable fee. The issuing agency/carrier must handle ticket reissue transactions.

# **Incentives and Awards**

Delta shall provide the Meeting Host with one (1) earned productivity certificate for every 40 round-trip tickets purchased and used in accordance with this agreement. The number of productivity certificates earned will be determined based on the number of tickets flown and NOT the number of tickets issued. Earned certificates, valid for travel on Delta operated flights, will be provided within 8-12 weeks of program completion and are subject to blackout dates and private booking inventory.

## **Terms and Conditions**

- Use of fares provided pursuant to this contract by anyone other than named party is strictly prohibited.
- This contract may not be assigned, transferred or otherwise conveyed to any third party without the prior written consent of Delta.
- Modifications or amendments of this agreement are not permitted without the prior written consent of each parties.
- Delta reserves the right to release seat blocks at such a time that the terms outlined in this agreement are not met.
- This agreement may be cancelled, with or without cause, upon 15 days prior written notice to the other party.
- In the event of a breach of this contract by a party hereto which the aggrieved party reasonably determines to be material, this agreement may be terminated by the aggrieved party immediately upon written notice to the other party.
- If Customer cancels this contract before the end of the term, Customer will not be refunded any previously remitted deposits and will also be responsible for any penalties as a result of minimum production requirements herein not being met.
- This contract is offered based on a minimum production of ten (10) flown revenue passengers traveling on Delta. If such a minimum is not met, the discounted fare provided hereunder will no longer apply. All passengers must be ticketed (or re-ticketed) at the applicable published fare in effect at time of ticketing.
- All promotional materials that include Delta name or any of Delta's trademarks, service marks or other intellectual property are subject to Delta's prior approval.
- Space confirmed pursuant to this contract may not be released to a consolidator or any other third party.
- Delta is not always able to confirm specific seat requests and is unable to make adjustments once seats have been assigned.
- Delta will not be liable for flight delays or cancellations. Delta reserves the right to change equipment or schedules without notice.
- All transportation is subject to Delta's contract of carriage and applicable tariffs.
- This contract is confidential and shall not be disclosed by the customer to any third party, including without limitation, any travel agency or consolidator.
- For group block space of 10 or more passengers traveling on same flights, such group block space must be requested through your Delta Meeting Network Specialist. Terms and fares may vary.
- Dwyer Group is fully responsible for ensuring that any person or agency contracted on it's behalf adheres to all terms and conditions of this contract. Violation of these contract terms by Dwyer Group or any agency contracted on it's behalf may, among other things, result in the following: contract cancellation, debit memo issuance against Dwyer Group for the difference in the fare between the ticket issued improperly and the appropriate valid retail fare and legal action against Dwyer Group seeking recovery of lost profits.
